3	III-5 – III-6	<p>Foundation School Program Funding.⁴⁹ Out of the funds appropriated above, a total of \$20,914,551,44721,468,235,602 in fiscal year 202018 and \$20,569,521,76721,503,735,602 in fiscal year 202119 shall represent the sum-certain appropriation to the Foundation School Program. The total appropriation may not exceed the sum-certain amount. This appropriation includes allocations under Chapters 41, 42 and 46 of the Texas Education Code.</p> <p>Formula Funding: The Commissioner shall make allocations to local school districts under Chapters 41, 42 and 46 based on the March 20197 estimates of average daily attendance and local district tax rates as determined by the Legislative Budget Board and the final tax year 20186 property values. Property values, and the estimates of local tax collections on which they are based, shall be increased by 6.777.04 percent for tax year 20197 and by 6.77 percent for tax year 202018.</p> <p>For purposes of distributing the Foundation School Program basic tier state aid appropriated above and in accordance with §42.101 of the Texas Education Code, the Basic Allotment is established at \$5,140 in fiscal year 202018 and \$5,140 fiscal year 202119.</p> <p>For purposes of distributing the Foundation School Program enrichment tier state aid appropriated above and in accordance with §41.002(a)(2) and §42.302(a-1)(1) of the Texas Education Code, the Guaranteed Yield is \$112.2799.41 in fiscal year 202018 and \$118.50106.28 in fiscal year 202119.</p> <p>Included in amounts appropriated above and allocated by this rider to the Foundation School Program, \$23,750,000 in each fiscal year of the biennium out of the Foundation School Fund No. 193 is for the New Instructional Facilityies Allotment under §42.158 of the Texas Education Code.</p> <p>Included in amounts appropriated above and allocated by this rider to the Foundation School Program, \$50,000,000 in fiscal year 202018 and \$25,000,000 in fiscal year 202119 out of the Foundation School Fund No. 193 is for adjustments due to rapid property value decline pursuant to §42.2521 of the Texas Education Code.</p> <p>From the amount appropriated above to the Texas Education Agency for Strategy A.1.1, FSP – Equalized Operations, in each year of the 2020-2118-19 biennium, the Commissioner may not spend more than the amount</p>
